- You must be available to schedule for a pick-up within <u>6 working days</u> from the day we contact you or your return may be rejected.
- Your pick-up address must be the same as the delivery address that has been fulfilled by KHIND.
- This 30-day trial is limited to 1 washer dryer per household only.
- You will not be eligible for the 30-day trial period for any future orders on KHIND's Washer Dryers. We identify such customers based on name, household address, phone number, email address, or any other relevant information.
- The returned washer dryer must be in good condition. If the washer dryer is broken or damaged, you may not be granted a full refund. Additional charges may be incurred based on the degree of damages on the washer dryer, assessed by the technical team from KHIND Customer Service.
- We reserve all rights to refuse your return request if we believe that you are returning for reasons other than dissatisfaction with the product.
- If you are not at home during pick-up that is scheduled beforehand and our pick up team has to reschedule another visit within <u>3 days</u>, an additional RM150 pick-up fee will be charged to cover any additional expenses incurred for the pick-up.
