#### MODE OF MEETING

The 27th AGM of the Company will be conducted on fully virtual through live streaming and online voting via Remote Participation and Voting facilities via TIIH Online website at <a href="https://tiih.online">https://tiih.online</a>.

An online meeting platform used to conduct the meeting can be recognised as the meeting venue as required under Section 327(2) of the Companies Act 2016, provided that the online platform located in Malaysia and all meeting participants including the chairman of the meeting, board members, senior management and shareholders are to participate in the meeting online.

#### REMOTE PARTICIPATION AND VOTING ("RPV") FACILITIES

Shareholders are to attend, speak (in the form of real time submission of typed texts) and vote (collectively, "participate") remotely at the 27th AGM using RPV facilities from Tricor.

A shareholder who has appointed a proxy(ies) or attorney or authorised representative(s) to participate at this 27<sup>th</sup> AGM via RPV facilities must request his/her proxy(ies), attorney(s) or authorised representative(s) to register himself/herself for RPV at TIIH Online website at https://tiih.online.

Kindly refer to Procedures for RPV facilities as set out below for the requirements and procedures.

### PROCEDURES TO REMOTE PARTICIPATION AND VOTING VIA RPV FACILITIES

Please read and follow the procedures below to engage in remote participation through live streaming and online remote voting at the 27th AGM using the RPV facilities:

(i)	Register as a user with TIIH Online	<ul> <li>Using your computer, access the website at <a href="https://tiih.online">https://tiih.online</a>. Register as a user under the "e-Services", select the "Sign Up" button and followed by "Create Account by Individual Holder". Refer to the tutorial guide posted on the homepage for assistance.</li> <li>Registration as a user will be approved within one (1) working day and you will be notified via e-mail.</li> <li>If you are already a TIIH Online user, you are not required to register again. You will receive an e-mail to notify you that the remote participation is available for registration at TIIH Online.</li> </ul>

(ii)	Submit your request to attend 27th AGM remotely	<ul> <li>Registration is open from Wednesday, 26 April 2023 until the day of 27th AGM on Friday, 26 May 2023 at 10.00 a.m. Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to pre-register their attendance for the 27th AGM to ascertain their eligibility to participate in the 27th AGM using the RPV.</li> <li>Login with your user ID (i.e. email address) and password and select the corporate event: "(REGISTRATION) KHIND HOLDINGS BERHAD 27TH AGM".</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select "Register for Remote Participation and Voting"</li> <li>Review your registration and proceed to register</li> <li>The system will send an e-mail to notify that your registration for remote participation is received and will be verified.</li> <li>After verification of your registration against the General Meeting Record of Depositors as at 18 May 2023, the system will send you an e-mail after 24 May 2023 to approve or reject your registration for remote participation.</li> <li>(Note: Please allow sufficient time for approval of new user of TIIH Online and registration for the RPV facilities).</li> </ul>

(iii)	Login to TIIH Online	Login with your user ID and password for remote participation at the 27 <sup>th</sup> AGM at any time from 9.00 a.m. i.e. 1 hour before the commencement of the 27 <sup>th</sup> AGM on Friday, 26 May 2023 at 10.00 a.m	
(iv)	Participate through Live Streaming	<ul> <li>Select the corporate event: "(LIVE STREAM MEETING) KHIND HOLDINGS BERHAD 27<sup>th</sup> AGM" to engage in the proceedings of the 27<sup>th</sup> AGM remotely.</li> <li>If you have any question for the Chairman/ Board, you may use the query box to transmit your question. The Chairman/ Board will endeavor to respond to questions submitted by remote participants during the 27<sup>th</sup> AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.</li> </ul>	
(v)	Online Remote Voting	<ul> <li>Voting session commences from 10.00 a.m. on Friday, 26 May 2023 until a time when the Chairman announces the closure of the session.</li> <li>Select the corporate event: "(REMOTE VOTING) KHIND HOLDINGS BERHAD 27<sup>TH</sup> AGM" or if you are on the live stream meeting page, you can select "GO TO REMOTE VOTING PAGE" button below the Query Box.</li> <li>Read and agree to the Terms &amp; Conditions and confirm the Declaration.</li> <li>Select the CDS account that represents your shareholdings.</li> <li>Indicate your votes for the resolutions that are tabled for voting.</li> <li>Confirm and submit your votes.</li> </ul>	
(vi)	End of remote participation	Upon the announcement by the Chairperson on the closure of the 27 <sup>th</sup> AGM, the Live Streaming will end.	

## Note to users of the RPV:

- 1. Should your application for the RPV facilities be approved, we will make available to you the right to join the live stream meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- 2. The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

# Administrative Guide For The Twenty-Seventh Annual General Meeting

#### **Entitlement to Participate and Appointment of Proxy**

- Only members whose names appear on the Record of Depositors as at 18 May 2023 shall be eligible to attend, speak and vote at the 27<sup>th</sup> AGM or appoint a proxy(ies) and/or the Chairman of the Meeting to attend and vote on his/her behalf.
- If you are not able to participate in the 27<sup>th</sup> AGM remotely, you are encouraged to appoint the Chairman of the Meeting as his/her proxy and indicate the voting instruction in the Form of Proxy.
- If you wish to participate in the 27<sup>th</sup> AGM yourself, please do not submit any Proxy Form for the 27<sup>th</sup> AGM. You will not be allowed to participate in the 27<sup>th</sup> AGM together with a proxy appointed by you.
- Accordingly, Proxy Forms and/or documents relating to the appointment of proxy/corporate representative/ attorney for the 27<sup>th</sup> AGM whether in hard copy or by electronic means shall be deposited or submitted in the following manner not later than **Wednesday**, 24 May 2023 at 10.00 a.m:

Proceed with submission of Proxy Form	<ul> <li>After the release of the Notice of Meeting by the Company, login with your username (i.e. email address) and password.</li> <li>Select the corporate event: "Khind Holdings Berhad 27th AGM - Submission of Proxy Form".</li> <li>Read and agree to the Terms and Conditions and confirm the Declaration. Insert your CDS account number and indicate the number of shares for your proxy(ies) to vote on your behalf.</li> <li>Appoint your proxy/proxies and insert the required details of your proxy/proxies or appoint the Chairman as your proxy.</li> <li>Indicate your voting instructions – FOR or AGAINST, otherwise your proxy will decide on your votes.</li> <li>Review and confirm your proxy(ies) appointment.</li> <li>Print the form of proxy for your record.</li> </ul>

Register as a User with TIIH Online	<ul> <li>Access TIIH Online at <a href="https://tiih.online">https://tiih.online</a></li> <li>Under e-Services, the authorised or nominated representative of the corporation or institutional shareholder selects "Create Account by Representative of Corporate Holder".</li> <li>Complete the registration form and upload the required documents.</li> <li>Registration will be verified, and you will be notified by email within one (1) to two (2) working days.</li> <li>Proceed to activate your account with the temporary password given in the email and re-set your own password</li> </ul> Note: The representative of a corporation or institutional shareholder must register as a user in accordance with the above steps before he/she can subscribe to this corporate holder electronic proxy submission. Please contact					
	our Share Registrar if you need clarifications on the user registration.					
Proceed with submission of Proxy Form	<ul> <li>Login to TIIH Online at <a href="https://tiih.online">https://tiih.online</a></li> <li>Select the corporate event: "Khind Holdings Berhad 27th AGM: Submission of Proxy Form"</li> <li>Agree to the Terms &amp; Conditions and Declaration.</li> <li>Proceed to download the file format for "Submission of Proxy Form" in accordance with the Guidance Note set therein.</li> <li>Prepare the file for the appointment of proxies by inserting the required data.</li> <li>Login to TIIH Online, select corporate event: "Khind Holdings Berhad 27th AGM - Submission of Proxy Form".</li> <li>Proceed to upload the duly completed proxy appointment file.</li> <li>Select "Submit" to complete your submission.</li> <li>Print the confirmation report of your submission for your record.</li> </ul>
